Subject: COVID-19 At-Home Test Kit Coverage

WVCHIP covers at-home, self-administered COVID-19 test kits for members without a prescription effective January 15, 2022. Coverage is provided for eight (8) over-the-counter (OTC) at-home COVID-19 self-test kits every 30-days per member. No prescription (doctor's order) is required for coverage. This coverage is provided at no cost to the member. No copayments are required.

WVCHIP covers COVID-19 at-home test kits by the following two methods:

- 1) Direct Coverage:** CVS Caremark in-network pharmacies will dispense OTC COVID-19 tests to members with no upfront out of pocket cost. Direct coverage is limited to the following test kits:

- 2) Post-Service Member Reimbursement:** CVS Caremark will process member reimbursements for OTC COVID-19 tests purchased without a prescription beginning January 15, 2022. Under this option, the member pays for the test and then submits a claim to CVS Caremark. There are two options to submit claims: 1) members may download a paper prescription claim form at

<https://chip.wv.gov/SiteCollectionDocuments/OTC%20COVID%20Test%20Paper%20Claim%20Form.pdf> and follow the instructions; or 2) members may go to <https://www.caremark.com/covid19-otc> and create an account, submit a copy of the receipt and request reimbursement. To be eligible for reimbursement under this option, test must meet the following criteria:

- must be purchased on or after January 15, 2022,
- must be for personal diagnostic use,
- used to identify the potential COVID-19 infection,
- must be self-administered with results that can be self-read,
- will not be resold, given, or supplied to persons other than the member, and,
- will not be reimbursed by another source.
