



Colorectal Cancer Screening (COL)

HEDIS® Measurement Year 2022 Measures

Measure Description: Members age 45 to 75 who had appropriate screening for colorectal cancer. Appropriate screenings are defined by one of the following:

- Fecal occult blood test (FOBT) during the measurement year.
- Flexible sigmoidoscopy during the measurement year or the four years prior to the measurement year.
- Colonoscopy during the measurement year or the nine years prior to the measurement year.
- Computerized tomography (CT) colonography during the measurement year or the four years prior to the measurement year.
- Stool DNA (sDNA) with FIT test (Cologuard®) during the measurement year or two years prior to the measurement year.

Eligible Population

- Members 45 to 75 years of age who had an appropriate screening for colorectal cancer.
- Members who are in hospice or palliative care are excluded from the eligible population.

Strategies for Improvement

- Discuss the importance of colorectal cancer screenings and ensure your patients are up to date with their colorectal cancer screening.
- Clearly document past medical and surgical history in the medical record, include dates and results.
- Clearly document all surgical and diagnostic procedures in the medical record, include dates and results.
- Use correct diagnosis and procedure codes.
- Submit claims and encounter data in a timely manner

Exclusions

- Members with a history of colorectal cancer or total colectomy any time through December 31 of the measurement year.
- Members 66 years of age and older as of December 31 of the measurement year with frailty and advanced illness during the measure year.
