

Child and Adolescent Well Care Visits (WCV)

HEDIS® Measurement Year 2022 Measures

Measure Description: The percentage of members 3–21 years of age who had at least one comprehensive well-care visit with a PCP or an OB/GYN practitioner during the measurement year.

Eligible Population

 Members 3–21 years of age as of December 31 of the measurement year.

Strategies for Improvement

- Utilize NCQA coding tips to actively reflect care rendered.
- Educate staff to schedule visits within the time frames.
- Never miss an opportunity to perform a well-child exam, even during a sick visit.
- Educate staff to schedule visits within the quideline time frames.

Components of a Well-Child Visit

The well-child visit must occur with a PCP or OB/GYN type practitioner, but the practitioner does not have to the practitioner assigned to the child.

Preventive services may be rendered on visits other than well-child visits. Well-child preventive services count toward the measure, regardless of the primary intent of the visit, but services that are specific to an acute or chronic condition do not count toward the measure.

The following are some examples of acceptable criteria for all the components in a well-child visit:

- Health History
- Physical Developmental History
- Mental Developmental History
- Physical Exam
- Anticipatory Guidance
